OTHER:

1. Anticipate **25** firing points per relay. Each club/school/JROTC unit, etc., entering teams are initially guaranteed entry of two teams. Thereafter, entry will be on a space available, first come, first serve basis. Receipt of entry fees is required to validate entry and relays.

Teams from out-of-town which are spending Friday will have priority for relay assignment on either Friday or Saturday.

Out-of-Town teams should have their payment and registration received NLT November 7, 2010. On Nov 8, 2010 any unreserved relay slots will be opened to additional teams/individuals and local area teams/individuals for reassignment.

Albuquerque Area teams --- anticipate shooting on Thursday or Friday. On Nov 10 you may request new relay times from those slots not yet filled. See the below link for details:

- 2. **NJROTC Instructors** must remain with their shooters in the range area while their shooters are on the firing line.
- 3. <u>CMP Individual ID #'s</u>. This is a CMP Cup Match and EIC points may be earned. Participants should ensure they have registered with the CMP and received CMP ID number. *Note: These numbers can be generated when the roster is received and at the match if necessary.*
- 4. Be at the range a <u>minimum of one (1) hour prior</u> to relay time. Remember, preparation time begins 10 minutes prior to relay "START" time.
- 5. Changing rooms will be available. Changing to be accomplished off-range to expedite change-over between relays.
- 6. CO² and compressed air refills available.

Individuals and teams are responsible for their own air tank adapters. Daisy Avanti 888/887 standard adapter will be on the CO2 tank.

- 7. Shooters requesting Relay #8 on Day 3 are requested to stay and help tear down the range after the Final.
- 8. Rule 10.1.6 will be invoked to fire a FINAL at the conclusion of each competition day.

10.1.6 Multiple Finals for Multi-Day Events

In competitions with multiple relays that take place over two or more days, where it is not possible to have the top eight competitors remain for a single eight-person final at the end of the competition, the Competition Program may, alternatively, provide that the competitors with the eight highest scores for that day will complete a ten-shot final round at the end of each day. The same finals procedures that are given in this Rule must be used. If this special finals procedure is used, the final round scores will be added only to the scores of the shooters who had the eight highest 3x10 or 3x20 scores overall to determine the final ranking of those eight competitors. The final round scores of all other competitors may be published in the results bulletin for information purposes, but will not be counted in the final rankings.
