## 4-H Rimfire Ammunition Program for 2010 Season

1. YOU MUST PLACE YOUR ORDER BY **NOVEMBER 25<sup>th</sup> 2009**.
2. Only product # **510** (Federal Champion target .22LR) will be available.
3. A maximum of **4 cases** per county/team may be requested (20,000 rounds). Depending on the volume of orders, *we may allocate less than you request.*
4. **Only team coaches or county Extension agents may place the order**- no individual orders. Every order must include a letter from the county Extension agent confirming that the club is a functioning 4H shooting sports project, and that the order is for the club.
5. **CREDIT CARD SALES ONLY.** (Because we may only allocate a portion of your request, we need the flexibility to bill you only for the product we ship.)
6. We anticipate shipping in early December. Your credit card will be billed at that time.
7. You will be billed for your local and state sales tax unless you include a **Sales Tax Exemption Certificate**.
8. You must include an **e-mail address** for the person managing your request so we can provide them with information as needed.
9. We only have 1.25 million rounds available for this special offer, and will distribute them in a manner to ensure the most number of programs can benefit.

*WE DO NOT ANTICIPATE OFFERING ANY OTHER YOUTH RIMFIRE DIRECT SALES IN 2010.* When the demand for rimfire slows and we are able to reduce our backorders to improved levels we will again offer an array of rimfire products to approved youth programs. Based on current backlogs, that will be 2011.

No other products are available- including 711B or 719. If you have a previous order in for those products that is on backorder, those will be filled as those products are run.
